

# EJaRt Creative Festive Art Market Terms & Conditions

## What Kind of Art is Accepted?

Artists/Makers can exhibit paintings, drawings, prints, ceramics, sculpture, glass, wood, jewellery and more.

All items must be the Artist's/Maker's own designs/creations. They should either be made by the Artist/Maker and/or produced on a small scale.

Bought in trade items, or commercially manufactured items, will not be accepted and you may be asked to remove these from your display.

#### **How Much Does it Cost?**

The fee is £35 for each day booked. You will pay for this after your application has been accepted.

#### What is Provided?

The art market will be held inside at EJaRt Creative. There are two rooms and EJaRt Creative will allocate you a space.

There are 2 options available to display your work:

#### **Table**

One table and a chair will be provided per artist/maker by EJaRt Creative.

You will need to provide a table covering.

Various table sizes are available:

- 120cm x 80cm
- 160cm x 80cm
- 180m x 76cm
- 120cm x 60cm.

If you do have a preference, please specify at the time of application. These will be allocated on a first come, first served basis.

#### **Wall Space**

We can also offer wall space as an alternative for those who would prefer to hang their work.

It will be a grid wall mesh hanging display and you will have an area of 120cm (wide) by 180cm (high) for hanging, you will have 60cm in front of your wall space for a chair and small print browser if desired.

You will need to provide S-hooks to hang your work.

Wall spaces are limited in number and will be allocated on a first come, first served basis, so please let us know at the time of application.

#### **Dates and Times**

- The market will be open to the public from 10am to 4pm on both days: Saturday
   November & Sunday 1 December 2024
- 2. Displays can be set up from 8.30am. If you are attending both days you can leave your stall set up overnight if you wish.
- All displays must be manned, stocked and open to the public by the start time of the market.
- 4. No display should be dismantled before the end of the market.

### **Booking Procedure**

- Please complete the online application form on our website: www.ejartcreative.co.uk
- 2. We will contact you to let you know if your application has been successful.
- 3. Artist/Maker's must provide photos of examples of artwork/products when applying.
- 4. Not all applications will be successful. We wish to have a good/varied mix and quality of arts/crafts. EJaRt Creative reserves the right to refuse applications without having to justify its decision.
- 5. All applications will be taken on a first-come, first-served basis.

- 6. After EJaRt Creative has confirmed that your application has been successful, payment must be made in full.
- 7. Places are only secured, after EJaRt Creative has received full payment and has sent written approval to the Artist/Maker.
- 8. Allocation of places at the art market is at the sole discretion of EJaRt Creative.
- 9. Confirmation of successful applications will be sent via email.
- 10. Receipts for payment of places can be issued if required, please ask.
- 11. EJaRt Creative/Grange Farm Hasketon Facilities:
  - Public toilets are located onsite, around the corner from EJaRt Creative.
  - There is a café on site (Barn Café) for purchasing refreshments.
  - There is a farm shop directly opposite EJaRt Creative where you can buy snacks/drinks etc if required.
  - There is onsite parking for customers. Artist/Maker parking may be off site (please refer to the loading/unloading section in this document).

### **Loading and Unloading**

- On the market days, Artists/Makers are welcome to park outside in the car park (ensuring not to block access to the other businesses on the Grange Farm site) whilst they unload.
- 2. After stock has been unloaded, cars must be moved immediately to our designated car park. This may be off-site. Directions will be provided and we will run a shuttle vehicle back and forth if required.
  - (Artist/Makers parking off site will allow customers ample parking on the Art Market days.)

## **Cancellation Policy:**

- 1. Cancellations must be received in writing and receipt confirmed by EJaRt Creative.
- 2. No refund is possible if the cancellation is made less than 28 days before the market date. Notification of more than 28 days will receive a full refund.
- 3. If for whatever reason, EJaRt Creative cancels the market, a full refund will be made to you.

#### **No Shows**

- 1. If an Artist/Maker does not show up to the event, without any notification, they will not receive a refund.
- 2. Applications for future events hosted by EJaRt Creative may not be approved and you may be unable to exhibit at any of our other events.

## **Health and Safety/Insurance**

- 1. Artists must obtain, and provide evidence of, valid Public Liability Insurance prior to the event. Please email this to <a href="mailto:hello@ejartcreative.co.uk">hello@ejartcreative.co.uk</a> with your name as the subject after you have completed the application form.
- 2. EJaRt Creative cannot be held responsible for injury or accident caused by an Artist/Maker's product or display, loss of profits, damage or theft of stock.
- 3. All displays, stands and artwork/products must be safe, inoffensive and portable.
- 4. EJaRt Creative has the right to ask Artist/Makers to remove any of the exhibits or make alterations to their display if deemed unsuitable or they create a hazard.
- 5. All artwork/products, display stands and personal belongings are the responsibility of the Artist/Maker.
- 6. No naked flames are permitted inside the EJaRt Creative building.
- 7. Electrical installations may only be used with prior agreement and may be subject to an additional charge.
- 8. Please leave your space as you found it and clear any rubbish/debris.
- 9. Fire exits must be kept clear at all times.
